

ADVERTISEMENT FOR BIDS

Sealed bids will be received at the office of the Clerk of the Board of Tuscarawas County Commissioners, 125 East High Avenue, New Philadelphia, Ohio 44663 until 9:30 am on February 17, 2011 for Project #1-2011 – Bridge Deck Waterproofing & Paving, Project #2-2011 – Bridge Guardrail and Project #3-2011 – Roadway Centerline Striping.

Plans, specifications and contract documents are on file for Projects #1-2011, 2-2011 and 3-2011 in the office of the Tuscarawas County Engineer, 832 Front Ave. SW, New Philadelphia, Ohio 44663. Copies may be obtained upon payment of a non-refundable fee of \$30.00 for each set of documents. Checks shall be made payable to "Tuscarawas County Engineer." Shipping and handling charge of \$15.00 will apply to all requests for shipping plans and specifications. The specifications and plans may also be obtained electronically free of charge via e-mail by contacting the County Engineer's Office at engineer@co.tuscarawas.oh.us.

Work will consist of furnishing all services, labor, materials and equipment necessary to perform work as per specifications set forth by the Tuscarawas County Engineer. Specifically, the projects will consist of the following:

Project #1-2011 - Bridge Deck Waterproofing and Paving

-Furnish and install ODOT Item 512.08 Type 3 Membrane Waterproofing, primer and asphalt concrete on new precast concrete box beam bridges constructed by County Forces at approximately six (6) locations throughout the 2011 construction season and four (4) existing bridges during the construction season.

-Patch paving, berming and planing, as directed, for paving repairs at intersection improvement projects if required, throughout the 2011 construction season

Project #2-2011 - Bridge Guardrail

-Furnish and erect all guardrail and appurtenances across bridge decks and approach roadways as per plan at six (6) locations throughout the 2011 construction season.

Project #3-2011 – Roadway Centerline Striping

This project consists of T-marking, layout and pre-marking and furnishing and supplying waterbourne centerline striping on approximately 50 miles of County Roads in a single phase.

Bids shall be in conformity with the Ohio Revised Code, and shall be upon the forms furnished in the Contract Documents. Bids must be submitted in a sealed envelope, bearing on the outside, the name and address of bidder and the name of the project, "PROJECT #1-2011 TUSCARAWAS COUNTY," "PROJECT #2-2011 TUSCARAWAS COUNTY" or "PROJECT #3-2011 TUSCARAWAS COUNTY" as appropriate.

Projects #1 and 2 are funded in part by the Ohio Public Works Commission and are subject to funding agency regulations.

Each bid shall be accompanied by a bid guaranty in the form of (1) a certified check, cashier's check or irrevocable letter of credit pursuant to ORC 1305 equal to 10% for the bid; or (2) a bid guaranty and contract bond for the full amount of the bid; both forms of guaranty as provided in Chapter 153 of the Ohio Revised Code and in the project specifications. All bid guarantees shall be conditioned that if the bid is accepted within sixty (60) days of the bid opening, a proper contract shall be executed, and that upon failure or refusal to enter in to said contract within ten (10) days after the receipt of notification of award, the bidder and the surety on any bond shall be liable to the County in an amount not to exceed ten (10) percent of the bid.

Attention is called to the prevailing wage rates to be paid where applicable for labor and public improvements in and for Tuscarawas County, as ascertained by the Department of Industrial Relations of the State of Ohio.

The bonds or checks of all unsuccessful bidders will be returned within 48 hours after award of the contract or the rejection of all bids.

Each bid and all certificates shall be upon the forms furnished with the specifications, and shall be delivered to the Clerk of the Board of Tuscarawas County Commissioners on or prior to the date and hour specified for receiving bids.

Bidders shall comply with the Affirmative Action-Equal Employment Opportunity requirements set forth in the Contract Documents. A bidder/contractor will be deemed committed to the goal of such bid conditions by submitting a properly signed bid. Each bidder must insure that all employees and applicants for employment are not discriminated against because of race, color, religion, sex, handicap, or national origin.

The Tuscarawas County Commissioners reserve the right to reject any or all bids, and to waive any informalities or irregularities in the bids received.
