

**Tuscarawas County**  
**Specifications for the Purchase of**  
**One (1) Used 2003 or newer Chip Spreader with 10' to 20' variable width spread hopper**

General:

1. Unit must meet all minimum specifications. Any exceptions to these minimum specifications must be clearly noted on the sheet titled "Exceptions to the Specifications" and submitted with the bid. Bidders may provide bids for multiple units if available for consideration.
2. Bidder may submit prices for a used Chip Spreader meeting these minimum specifications. Used units shall be 2003 or newer model year and have less than 4700 documented hours.
3. Unit shall be delivered F.O.B. to New Philadelphia, Ohio, within thirty (30) days of bid award. All freight costs to be included in the price bid.
4. All bids to be submitted in a sealed envelope marked "Used Chip Spreader" and must be received before 9:15 pm on March 10, 2016 at the office of the Clerk of the Board of Tuscarawas County Commissioners, 125 East High Avenue, New Philadelphia, Ohio 44663.

Minimum Specifications for Used Chip Spreader:

- 2003 or newer, Etnyre or equal, Chip Spreader
- 4 wheel drive – Hydrostatic drive
- 10' to 20' variable width spread hopper with 1' electrical/air gates full width
- 4700 maximum documented hours
- power seat pedestal
- front tenders
- 260 SAE net engine horsepower minimum, turbo charged diesel engine
- automatic conveyor control
- receiving hopper to be a minimum of 11' wide with approximate 4 cy capacity and folding wings
- full hydrostatic power steering
- heavy duty 24" wide conveyor belts, independently activated
